BUILD-PAC Basics

What is BUILD-PAC?

BUILD-PAC, or Builders United in Legislative Decisions Political Action Committee, is the political arm of the National Association of Home Builders (NAHB). BUILD-PAC helps elect the most qualified pro-housing, pro-business candidates to federal office.

Does BUILD-PAC favor Democrats or Republicans?

BUILD-PAC is bipartisan and supports pro-housing, pro-business candidates on both sides of the aisle.

Who determines which candidates receive BUILD-PAC's support?

You! BUILD-PAC's 100+ Board of Trustees, made up of NAHB members, decides which candidates receive support. State Trustees, who advocate for BUILD-PAC at the local level, are nominated by State leadership.

Who can contribute to BUILD-PAC?

Only NAHB members can be invited to support BUILD-PAC and its efforts.

Does BUILD-PAC accept corporate contributions?

BUILD-PAC is legally permitted to accept personal money. It is illegal for a political action committee to contribute corporate contributions to congressional candidates.
